Council Member Key made the motion to approve and adopt Resolution 2016-237 to accept the lowest responsible bid from Custom Cutt's, LLC in the amount of \$32,250.00, for Ground Maintenance at the Lee County Park and the Future Soccer Complex and approve the Mayor to enter in a three year contract. Council Member Cooley Seconded the motion.

After discussion Council Member Jackson made the motion to amend the motion to extract Area 9. Future Soccer Complex to be cut by bush hog two times during the growing season.
The motion failed for lack of a second.

Mayor Dellinger called for the vote on the previous motion by Council Member Key. The vote was as follows:
