
WHEREAS, the City of Smiths Station Planning Commission is committed to and understands the vital nature of sharing information for the improvement of all in the City.

NOW THEREFORE, BE IT RESOLVED the City of Smiths Station Planning Commission amends the Planning Commission By-Laws, Section VI, Regular Meetings, paragraph 1 to read:

Section VI. Regular Meetings

Regular meetings of the Smiths Station Planning Commission shall convene at the Smiths Station City Hall at the following days and time: The Work Session and Planning Commission meeting will be held on the first Tuesday of each month. The Work Session shall begin at 6:30 P.M. and may be continued after the Regular Planning Commission Meeting is adjourned. The Regular Planning Commission Meeting shall begin at 7:00 P.M. All meetings, Regular and Special shall be open to the public. A regular meeting may be canceled by the Commission at a prior meeting or by the Chairman of the Smiths Station Planning Commission when he/she is aware that a quorum will not be present. A regular meeting may be rescheduled at a different time, place or date by the Planning Commission at a prior meeting.
