

ORDINANCE 2016-118

AN ORDINANCE OF THE CITY OF SMITHS STATION, ALABAMA, TO ESTABLISH THE SPEED LIMIT AND A DESIGNATED REDUCED SPEED SCHOOL ZONE ON LEE ROAD 728 WITHIN THE CITY LIMITS OF SMITHS STATION, ALABAMA.

BE IT ORDAINED BY THE CITY COUNCIL OF; SMITHS STATION, ALABAMA, AS FOLLOWS:

Section 1. On July 26, 2016; the City of Smiths Station City Council voted to establish the speed limit on Lee Road 728.

Section 2. No person shall operate a motor vehicle at a speed greater than 25 miles per hour on Lee Road 728, which is located within the City Limits of the City of Smiths Station, Alabama.

Section 3. No person shall operate a motor vehicle at a speed greater than 15 miles per hour on Lee Road 728, in a **DESIGNATED REDUCED SPEED SCHOOL ZONE** per Code of Alabama 1975 Section 32-5A et seq. which is located within the City Limits of the City of Smiths Station, Alabama.


Section 4. In addition to all provisions of law relating to the speed and operation of motor vehicles in the City of Smiths Station, Alabama, there is adopted by the City of Smiths Station, Alabama, all laws of the State of Alabama, pertaining to speed limits as set forth in the Code of Alabama 1975.

Now therefore be it ordained by the City Council of Smiths Station, Alabama, that this ordinance becomes effective immediately upon adoption and approval.


