A RESOLUTION TO AMEND THE CITY OF SMITHS STATION PLANNING COMMISSION BY LAWS, SECTION I, MEMBERSHIP, IN ACCORDANCE WITH THE PROVISIONS OF TITLE 11, CHAPTER 52, ET SQ. CODE OF ALABAMA, 1975, AS AMENDED.


WHEREAS, the City of Smiths Station Planning Commission, in accordance with Section 11-52-31 of the Code of Alabama, 1975, as amended, is empowered to adopt and amend the Planning Commission By Laws, and

WHEREAS, the City of Smiths Station aspires to remain consistent with the State of Alabama Code of 1975 Section 11-52-3 (a) paragraph 1 et seq.

NOW THEREFORE, BE IT RESOLVED the City of Smiths Station Planning Commission amends the Planning Commission By Laws, Section I to read:

The Smiths Station Planning Commission shall be composed of nine (9) residents of the City of Smiths Station. The mayor is authorized to appoint six (6) members serving the following terms of office: six (6) years, five (5) years, four (4) years, three (3) years, two (2) years, and one (1) year. The other three members are from the City Council with a Council Member appointed by the City Council serving during their tenure in office, the Administrative Officer appointed by the Mayor serving during the tenure of the Mayor and the Mayor, or his or her designee serving during his/her tenure as Mayor.


