

ORDINANCE 2017-129

AN ORDINANCE OF THE CITY OF SMITHS STATION, ALABAMA, REQUIRING VENDORS TO COMPLETE AN OFFICIAL SPORTS COMPLEX VENDOR APPLICATION GRANTING PERMISSION TO CONDUCT BUSINESS AT THE LEE COUNTY PARK AT SMITHS STATION.

WHEREAS, The City of Smiths Station has an obligation to manage the activities, implement consistent policies and procedures and maintain general order at the Lee County Park at Smiths Station, and;

WHEREAS, it is the responsibility of the City to establish enforceable ordinances and regulations, and;

WHEREAS, The City requires all persons, corporations, companies or other entities engaging business within the municipal limits to obtain a business license per Ordinance 2007-049, supported by the Title 11, Chapter 52, Article 2 of the Code of Alabama 1975, as amended, and;

WHEREAS, The City advocates consistency of Its Ordinances with the State of Alabama of Alabama.


NOW THEREFORE BE IT ORDAINED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF SMITHS STATION, ALABAMA as follows:


That the City Council of the City of Smiths Station, Alabama does hereby adopt the practice of requiring all persons, corporations, or other entities interested in conducting business or commerce at the Lee County Park at Smiths Station to obtain a Vendor Permit issued by the City of Smiths Station, sign a City of Smiths Station Sports Complex Vendor Permit Affidavit (Attachment A), abide by all conditions set therein, including but not limited Smiths Station Ordinance 2007-049 and the Code of Alabama, 1975, as amended.

All ordinances, or parts or ordinances heretofore adopted by the City Council of the City of Smiths Station, Alabama that are inconsistent with the provisions of the ordinance are hereby repealed.




