A RESOLUTION FOR THE CITY OF SMITHS STATION, ALABAMA TO ESTABLISH REGISTRATION AND LEAGUE FEES FOR USAGE OF THE LEE COUNTY PARK AT SMITHS STATION.

BE IT RESOLVED AND ORDERED BY THE CITY COUNCIL OF SMITHS STATION, ALABAMA as follows:

WHEREAS, Lee County, Alabama, has provided a park for the use of the citizens of Smiths Station; and,

WHEREAS, The City of Smiths Station has been entrusted with the maintenance, regulation, and general well-being of said park; and


WHEREAS, The City of Smiths Station is seeking a more effective method by which to offset expenses of which the park generates and to ensure that it is used for appropriate activities;

NOW THEREFORE, the City of Smiths Station approves that all current and future sanctioned athletic leagues including, but not limited to, Baseball, Softball, Football, Soccer as well as any additional sporting or non sporting activities that request and be granted playing privileges at or on the Sports Complex compensate the City of Smiths Station a "League Fee" of \$250.00 per league per season; and a \$15.00 Registration fee for each registration and;


Per Alabama Code 1975, 11-45-3 et seq., upon approval to become effective immediately for all future use of the Lee County Park at Smiths Station.

Resolution 2015-223 "Exhibit A", Section 1, paragraph 2, sentence 1, "City Leagues shall not be required to provide payment for use of the Smiths Station Sports Complex, with the exception of a deposit required prior to the beginning of each respective season and any damage charges which the league or leagues are deemed responsible for by the City, and any amendments to Resolution 2015-223, "Exhibit A", Section 1, paragraph 2, sentence 1 are hereby repealed.
